



SUD Institutions for Mental Disease (IMD) Billing Tip Sheet

Purpose:

Outline the guidance provided by DHHS to Residential Facilities with greater than 16 beds who provide Substance Use Disorder Services (SUD) and to support the CMS requirements for State reporting.

Overview:

The State of New Hampshire implemented a Section 1115(a) Demonstration Waiver in July 2018 that allows residential SUD treatment facilities with more than 16 beds (IMD's) to bill for NH Medicaid patients for as long as is medically necessary.

The Centers for Medicare and Medicaid Services (CMS) requires the state to report on the number of Medicaid recipients served under this waiver. To identify services covered under the SUD IMD Waiver, providers are required to use an informational code on all claims. DHHS-Program Integrity unit will be monitoring the claim submissions for accuracy and conduct periodic audits to validate correct use of the informational codes. As a result, improper billing may result in claim denials.

Requirements of IMD Billing:

- The SUD treatment facility must have more than 16 beds
- The member must be under age 65 and have a primary diagnosis of SUD
- Provider must bill with the required modifier or condition code on all claims (as outlined in the enclosed table)
