Description

Ezogabine (Potiga®) is a potassium channel opener oral anticonvulsant agent.

FDA approved indication

Potiga is indicated as adjunctive treatment of partial-onset seizures in patients aged 18 years and older who have responded inadequately to several alternative treatments and for whom the benefits outweigh the risk of retinal abnormalities and potential decline in visual acuity.

Policy/Criteria

Provider must submit documentation (including office chart notes and lab results) supporting that member has met all approval criteria

I. Initial Approval Criteria

A. Partial Seizures (must meet all):

1. Diagnosis of partial seizures;
2. Failure of 3 formulary alternatives (e.g., carbamazepine, diazepam, felbamate, gabapentin, lamotrigine, etc.) unless all are contraindicated or clinically significant adverse effects are experienced;
3. Potiga will be used for the adjunct treatment of partial seizures;
4. Dose does not exceed 1,200 mg per day.

Approval duration: 6 months

B. Other diagnoses/indications

1. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

II. Continued Therapy

A. Partial seizures (must meet all):

1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Potiga for partial seizures and has received this medication for at least 30 days;
2. Documentation of positive response to therapy;
3. If request is for a dose increase, new dose does not exceed 1,200 mg per day.

Approval duration: 6 months

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via health plan benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to HIM.PA.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized)

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – HIM.PHAR.21 or evidence of coverage documents
