Description

Sonidegib (Odomzo[®]) is a hedgehog pathway inhibitor.

FDA approved indication

Odomzo is indicated for treatment of adult patients with locally advanced basal cell carcinoma (BCC) that has recurred following surgery or radiation therapy, or those who are not candidates for surgery or radiation therapy.

Policy/Criteria

Provider must submit documentation (including office chart notes and lab results) supporting that member has met all approval criteria

I. Initial Approval Criteria

A. Basal Cell Carcinoma (must meet all):

1. Diagnosis of basal cell carcinoma;
2. Member meets one of the following (a or b):
 - a. FDA approved use (i and ii):
 - i. Locally advanced disease;
 - ii. Disease recurred following surgery or radiation therapy, or member is not a candidate for either;
 - b. Off-label NCCN recommended use: metastatic disease;
3. Dose does not exceed 200 mg per day (1 capsule per day).

Approval duration: 3 months

B. Other diagnoses/indications

1. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

II. Continued Therapy

A. Basal Cell Carcinoma (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
2. Documentation of positive response to therapy, including no disease progression;
3. If request is for a dose increase, new dose does not exceed 200 mg per day (1 capsule per day).

Approval duration: 6 months

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy; or
2. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

Approval duration: 6 months

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – HIM.PHAR.21 or evidence of coverage documents
