<p>Timely Filing <u>Claims with dates of service prior to January 1, 2018:</u> Providers will make best efforts to submit first time claims within 180 days of the date of service, however, claims will not be accepted for payment after 365 days of the date of service.</p> <p><u>Claims with dates of service on or after January 1, 2018:</u> Providers must submit first time claims within 90 days of the service.</p>	<p>Corrected Claims, Requests for Reconsideration or Claims Disputes 180 calendar days from the date of service and no more than 15 months for original date of service.</p>
