Medicaid Payment for Non-licensed Mental Health and Substance Use Disorder (SUD) Treatment Services

July 10, 2020

Dear Provider,

New Hampshire DHHS has published the following guidance on June 10, 2020 under Reference Number 20-0005: Medicaid Payment for Non-licensed Mental Health and Substance Use Disorder (SUD) Treatment Services.

NH Healthy Families will continue to follow the guidance outlined by DHHS as noted below:

- Authorizes payment for MCM Program covered services rendered by non-licensed mental health, and SUD treatment providers, actively working toward professional licensure when under the supervision of NH Medicaid licensed practitioners.
- Follows the conditions of payment outlined in the DHHS notice including:
 - Services are furnished directly by a non-licensed practitioner who works under the supervision of a licensed provider for purposes of accumulating clinical hours for purposes of New Hampshire licensure application;
 - The licensed provider is able to furnish the service being provided;
 - The state's Scope of Practice Act for the licensed practitioner specifically allows the licensed practitioner to supervise the non-licensed practitioner who furnishes the service:
 - The state's Scope of Practice Act also requires the licensed provider to assume professional responsibility for the patient and the service furnished by the unlicensed practitioner under their supervision; and
 - The licensed provider bills for the service.
- Allows NH Medicaid contracted mental health, alcohol and other drug use providers to bill for supervised Medicaid covered services delivered by a non-licensed practitioner actively working toward professional licensure:
 - Licensed physician certified in psychiatry by the American Board of Medical Specialties
 - Licensed psychiatric nurse practitioner
 - Licensed psychologist
 - Licensed marriage and family therapist
 - Licensed clinical mental health counselor

- Licensed clinical social worker
- Licensed pastoral psychotherapists
- Master Licensed alcohol and drug counselor
- The supervising provider must:
 - Be licensed and actively enrolled in NH Medicaid;
 - Only supervise for services within their scope of practice;
 - o Adhere to supervision requirements under the supervising provider's scope of practice;
 - o For SUD treatment services, adhere to supervision requirements of He-W 513;
 - Assume professional and legal responsibility for the non-licensed practitioner actively working toward professional licensure; and
 - For mental health supervisors, have a written candidate for licensure supervision agreement on record and approved by the licensing board before becoming effective.
- When billing Medicaid covered services rendered by a non-licensed practitioner actively working toward professional licensure, the licensed NH Medicaid provider NPI shall be included on claim forms.
- Services not eligible for reimbursement include:
 - Services rendered by any provider who is eligible to be enrolled as a NH Medicaid provider, but has not applied to be a NH Medicaid provider.
 - Services performed by a non-licensed provider who cannot practice independently, and is not actively working toward professional licensure.
