## SUD Facility Billing Guidelines Effective May 1, 2024

February 7, 2024

NH Healthy Families is in support of the state's efforts through the implementation of Pharmacotherapy for Opioid Use Disorder (POD). As communicated in various messages, billing changes have been adopted by NH Healthy Families on 1/1/2024.

**Effective May 1, 2024, NH Healthy Families is requiring the below billing guidelines to be followed. Claims that are not billed according to the guidelines may result in a denial.**

### Requirements of IMD Billing:

- The SUD treatment facility must have more than 16 beds
- The member must be under age 65 and have a primary diagnosis of SUD
- Providers must bill with required modifier or condition code on all claims (as outlined below)
